

Unlike the Florida statute reviewed in *Wilson*,⁵ the CDA's regulatory scheme requires only that the employee receive "written notification" before the investigation is begun. 41 C.F.R. In the absence of specific C.F.R. regulations on the manner in which an investigation shall be carried out, it would be within the discretion of the agency employee in charge of the investigation to choose between alternative procedures. Cf. *Sanchez v. Schweiker*, 532 F.Supp. 943, 948 (S.D.N.Y.1981) ("Where, however, the requirements of the C.F.R. provide only broad outlines to guide the employee in the conduct of an investigation, it will be within the employee's discretion to determine which investigatory procedures are necessary or desirable in a particular case.").
